

More than 230 voices were buzzing in harmonious jubilance on the night of July 30, 1988. It was the 38th celebration of the Williams-Hudson Family Reunion banquet, the climax of the reunion weekend.

This was a first for the California members to host the reunion. Traditionally the biennial celebration was held in either Birmingham, Alabama or Cataula, Georgia since the founding members, Nettie Paul Pleas and Lizzie McCotton reside there.

However, the California chapter reunion president, Purnell Williams, Jr. initiated a proposal at the 1986 reunion to bring it out west to California, and westward they came from Washington, D.C., New York, Chicago, Birmingham, Atlanta, San Francisco and Cataula ... the tall and the small ... the young and the old.

The weekend was ignited with a "Get Re-Acquainted Night" at the Airport Park Hotel. We were entertained by one of our own family members, Bonita Zeier, and her band, "Zamar." to a close, Toya Brown, a young lady who was not a family member, soothed us with a song entitled "If You Believe" from the musical "The Wiz." For some, when the program was over, the evening was over. They headed wearily up to their rooms content with their memories tucked in their minds, rekindled relationships tucked in their hearts and full stomachs tucked in their belts.
